Now comes, the Plaintiff Sharon Bridgewater and alleges and complains as follows:

FIRST CAUSE OF ACTION FOR BREACH OF CONTRACT

- 1. Plaintiff is an individual who resides in the city of Hayward, California.
- 2. Defendant is a Corporation and/or Partnership that conducts business is in the county of San Francisco, California.
- 3. The contract upon which this action is based was made was performed in the County of San Francisco, State of California.
